## Preparing to Submit the Undergraduate Business Scholarship Application

This sheet outlines the type of questions that will be asked on the undergraduate business scholarship application, which is usually available online by mid January each year. The questions will vary in order and amount of detail from those shown on this sheet, so be attentive when filling out the actual application.

**Personal Information:** Name, address, student number, citizenship and gender

**Race and Ethnicity:** Indicate your race/ethnicity.

**Areas of Study:** Indicate your majors, option(s), minor(s) and concentration(s).

**Transcript information:** Enter your credits, GPA and class standing.

**Financial Information:** Indicate scholarships, awards, employment and your financial picture in short answer format.

**Policy Exceptions:** Indicate intent to enroll full time or participate in study abroad or an internship.

### Current Activities and Applicable Employment History:

Enter a resume style list that describes your activities and employment history as it applies to items checked in Specific Scholarship Eligibility.

**Career Goals:** Describe long-term career goals in short answer format.

**Educational Goals:** Describe your educational goals in short answer format.

**Personal Essay:** In no more than one page, describe your college career, your goals after college and how the award of a scholarship will aid you in your goals. Include any personal information that will be relevant to the Scholarship Committee. You can elaborate upon any of your previous responses.

**Biography:** Write a short biography in 4-5 lines following an example given in the application.
